TYPE/AMOUNT OF PRODUCT SPILLED: 150 gallons of North Slope crude oil

LOCATION: Y Pad Well #1, North Slope

CAUSE OF SPILL: The pressure gauge on the S riser of the wellhead ruptured, allowing 150 gallons of crude oil to flow into the well cellar and on to the gravel pad. BPXA has stated that this release is not related to the gas line release that occurred on September 29, 2008.

POTENTIAL RESPONSIBLE PARTY (PRP): BPXA

RESPONSE ACTION: BPXA has dispatched a vacuum truck to remove the free standing crude oil.

SOURCE CONTROL: The source of the spill was controlled when the valve on the line was closed.

RESOURCES AFFECTED: The gravel pad under and around the well house.

FUTURE PLANS AND RECOMMENDATIONS: The recovered oil will be recycled. A plan for the removal of the contaminated gravel will be drafted for agency approval.

WEATHER: Overcast, 24 degrees F, winds west at 5 mph.
